

**Forensic Psychology

General Areas of Service: Forensic psychology is the interface between psychology and the law. All psychological services provided for the legal community are forensic psychological services. Forensic psychologists are employed by family, civil, and criminal courts. Most forensic psychologists provide services that are both forensic and clinical in nature.

Nature of Work: In the civil court, psychologists can be called on to provide assessments of whether someone was harmed by an event, such as a car accident or a sexual harassment case. In this area, the forensic psychologist might be required to provide treatment recommendations, analyze the specific treatment needs of an individual, and determine the potential cost of such treatment. In the family law court, they mainly assess the child's best interest in cases of parental disputes. Forensic psychologists are perhaps most recognized for their involvement in criminal law. Psychologists provide the courts with analysis regarding criminal insanity and trial competence. They help courts decide whether sex offenders are likely to re-offend or are dangerous. They provide information and recommendations necessary for jury selection, sentencing, grants of probation, and conditions of parole. Forensic psychologists are routinely called upon in death penalty cases to provide analysis of the intentions, motivations, and personality characteristics of the accused. In juvenile courts, they are often asked to help determine whether a youthful offender can be rehabilitated. They assist prosecutors, defenders, and law enforcement investigators in understanding a range of normal and criminal behaviors, sometimes serving as "criminal profilers."

Professional Training: A bachelor's degree in Forensic Psychology can lead to careers in law enforcement or parole and probation. Those wishing to pursue a career in profiling or court consulting go on to graduate school and obtain their master's or doctoral degree.

Job Outlook: According to the Bureau of Labor Statistics, "overall employment for psychologists is projected to grow 7 percent from 2023 to 2033, faster than the average for all occupations." (See www.bls.gov) The American Psychological Association (APA) reports that forensic psychologists are needed in "prisons, rehabilitation centers, police departments, courthouses, law firms, schools, government agencies or private practices." Those with a doctoral degree will enjoy the best job prospects, according to the APA. (See www.apa.org)

Earnings: Earnings vary widely depending on specialty and years of experience. PayScale.com reports that most forensic psychologists earned an annual base salary ranging from \$50,000 to \$125,000, with a median salary of \$79,000. (See payscale.com)
